## CREATING THE GENDER AND DEVELOPMENT (GAD) MONITORING AND EVALUATION TEAM OF THE MUNICIPALITY OF QUEZON

WHEREAS, Philippine Commission on Women, Department of the Interior and Local Government, Department of Budget and Management, and National Economic and Development Authority Joint Memorandum Circular no. 2013-01 entitled, "Guidelines on the Localization of the Magna Carta of Women" provides for the creation of the GAD Monitoring and Evaluation Team;

WHEREAS, the creation of the GAD M & E Team would strength the M & E System for genderresponsive programs and projects;

WHEREAS, there is a need to create a GAD M&E Team to assess the progress of GAD-related programs, projects and activities;

#### Section 2. FUNCTIONS.

#### The GAD M&E shall:

- a.Monitor the implementation of GAD-related programs, projects and activities in their respective offices and suggest corrective measures to improve implementation of GAD PPAs and GFPS activities;
- b. Evaluate the outcomes of the LGU GAD policies, programs and projects; and
- c. Submit GAD Evaluation Report to the DILG Regional Office at the end of the Local Chief Executive's three-year term.

#### Section 3. EFFECTIVITY.
