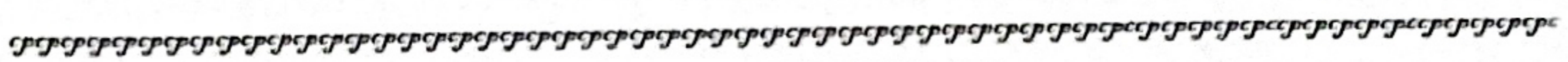

**REORGANIZING THE MUNICIPAL DEVELOPMENT COUNCIL AND MULTI-SECTORAL COMMITTEES
OF THE MUNICIPALITY OF QUEZON, PROVINCE OF QUEZON**

WHEREAS, Title Six, Section 106 of the Local Government Code of 1991 mandates each government a comprehensive multi-sectoral development plan to be initiated by its development council and approved by its Sanggunian, thereby assisting the Sanggunian in setting the direction of economic and social development efforts within territorial jurisdiction;

WHEREAS, 112 of Republic Act No. 7160, states that the local development councils may form sectoral or functional committees to assist them in the performance of their functions;

NOW, THEREFORE, I, MA. CARIDAD P. CLACIO, Mayor of the Municipality of Quezon, Province of Quezon, by virtue of the powers vested in me by law, do hereby order:

Section 1. **Reorganization of the Municipal Development Council (MDC).** The MDC shall be reorganized to be composed of the following:

Section 2. Duties and Responsibilities of MDC. The MDC shall exercise the following:

1. Formulate long-term, medium-term, and annual socio-economic development plans and policies;
2. Formulate the medium-term and annual public investment programs;
3. Appraise and prioritize socio-economic development programs and projects;
4. Formulate local investment incentives to promote the inflow and direction of private investment capital;
5. Coordinate, monitor, and evaluate the implementation of development programs and projects; and
6. Perform such other functions as may be provided by law or component authority.

Section 3. Meeting. The MDC shall meet at least once every six (6) months or as often may be necessary.

Section 4. Executive Committee. The MDC shall create an executive committee to represent it and act in its behalf when it is not in session. The composition of the executive committee shall be as follows:

The executive committee shall exercise the following powers and functions:

1. Ensure that the decisions of the council are faithfully carried out and implemented;
2. Act on matters requiring immediate attention or action by the council;
3. Formulate policies, plans, and programs based on the general principles laid down by the council; and
4. Act on other matters that may be authorized by the council.

Section 5. Multi-Sectoral Committees. - The multi-sectoral committees shall assist the MDC in the performance of their functions. It shall be composed of the following:
