REORGANIZATION OF THE MUNICIPAL ANTI-DRUG ABUSE COUNCIL (MADAC)

WHEREAS, Section 16 of RA 7160, otherwise known as the Local Government Code of 1991 mandates that Local Government Units shall, with their territorial jurisdictions, promote health and safety, improve public morals, maintain peace and order and preserve the comfort and convenience of the inhabitants;

WHEREAS, the proliferation and use of illegal drugs hamper overall efforts aimed at promoting productive family life, community peace and harmony and ultimately nation building and national development;

WHEREAS, national government efforts in subduing illegal drugs should be properly coordinated by the local government units to ensure harmonious relationship into the campaign of illegal drugs;

WHEREAS, DILG Memorandum Circular 98-227 dated December 2, 1998 supplemented by DILG Memorandum Circular 99-106 dated June 22, 1996 sets the guidelines in the creation of the Municipal Anti-Drugs and Abuse Council.

NOW, THEREFORE, I, MA. CARIDAD P. CLACIO, Municipal Mayor, of the Municipality of Quezon, by the powers by vested in me by law, do hereby order the following:

Section 1. Organization of the Municipal Anti-Drug Abuse Council. The Municipal Anti-Drug Abuse Council, herein referred to as MADAC is hereby constituted to act as general coordinating body in the formulation of policy guidelines and master plans and programs as well as in the implementation of projects that ensure the attainment of a drug-free community.

Section 2. Composition of MADAC. The MADAC shall be composed of the following:

Section 3. Duties and Functions of MADAC. - the MADAC shall perform the following duties and functions:

1. Serve as focal point through which various organization and individuals work together cooperatively in the planning, implementation and evaluation of programs on drug abuse prevention;
2. Provide for an effective mechanism for the coordination of existing services and programs and those which might developed in the future;
3. Provide for mechanism to obtain funds, volunteers, facilities and technical expertise; and
4. Perform other related duties and functions as may be assigned by the Local Chief Executive.

Section 4. Effectivity:

This Order shall take effect immediately.
