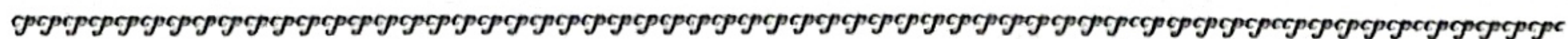

**RECONSTITUTING MUNICIPAL FISHERIES AND AQUATIC RESOURCE MANAGEMENT COUNCIL (MFARMC) IN THE MUNICIPALITY OF QUEZON**

WHEREAS, it is declared policy of state to ensure that management and control over fisheries and aquatic resources shall be effected by the Government through the active and extensive participation of people directly affected thereby;

WHEREAS, the existing fisherfolks have been seeking the enhancement of their empowerment through meaningful participation in the management, development and protection of fisheries and aquatic resources for sustainable productivity;

NOW, THEREFORE, I, MA. CARIDAD P. CLACIO, Municipal Mayor of the Municipality of Quezon, by virtue of the power vested in me by laws of the Republic of the Philippines, do hereby order the following:

Section 2. Functions. The MFARMC shall have the following functions:


1. Assist in the preparation of the Municipal Fishery development Plan and submit such plan to the Municipal Development Council.
2. Recommend the enactment of municipal fishery ordinances to the sangguniang bayan through its Committee on Fisheries.
3. Assist in the enforcement of fishery laws, rules and regulations in municipal waters.
4. Recommend to the sangguniang bayan on fishery matters through its Committee on Fisheries.
5. Harmonize and integrate into Fisheries Management Areas (FMAs) Program and submit plan to the municipal Development Council
6. Monitor and gather data in fish landing points as basis for the formulation of management plans and policies.

Section 3. Secretariat. The Secretariat will be from the Office of the Municipal Agriculturist.

Section 4. Funds. Funding of the Council will be taken from the budget of the Municipal Agriculture Office, partner NGOs and thru donations and grants.

Section 5. Effectivity. This Order shall take effect immediately upon approval.
