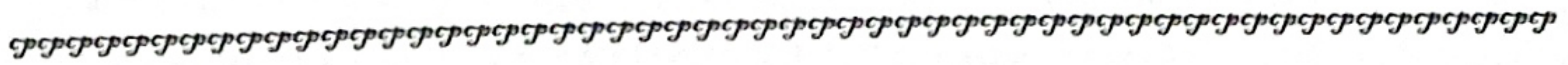

AN ORDER RECONSTITUTING THE MEMBERSHIP OF THE QUEZON, QUEZON CULTURE AND ARTS COUNCIL

WHEREAS, DILG Memorandum Circular No. 2017-133 dated 29 September 2017 provides for the creation of the Local Culture and Arts Council;

WHEREAS, in the said memorandum circular, there were additions in as far as the composition and functions by the Local Culture and Arts Council are concerned;

WHEREAS, there is a need to reconstitute the membership of the Quezon, Quezon Culture and Arts Council so that it may commence to discharge its powers and functions in accordance with the provisions in the aforementioned memorandum circular;

NOW, THEREFORE, I, MA. CARIDAD P. CLACIO, Municipal Mayor of the Municipality of Quezon, by virtue of the powers vested in me by law, do hereby order the following:

SECTION I. RECONSTITUTION. The membership of the Quezon, Quezon Culture and Arts Council is hereby called for reconstitution as follows:

Section II. Functions- The Quezon, Quezon Culture and Arts Council shall have the following functions:

- a. Prepare an annual plan on culture, arts, and cultural heritage consonant with the Philippine Development Plan for Culture and the Arts, to be integrated in the Local development plan and considered in the annual appropriations ordinances;
- b. Formulate programs and recommendations to develop and sustain local cultural and artistic talents, traditional and contemporary arts and crafts, and their processes;
- c. Coordinate with the appropriate affiliated cultural agencies of the National Commission for Culture and the Arts (NCAA) for the conservation and monitoring of national cultural properties found in the LGU;
- d. Conduct cultural events such as cultural festivals, competition, lectures, seminars and symposia;
- e. Identify such other programs and activities for the promotion of local cultural heritage and arts;
- f. Ensure the protection, preservation, conservation and promotion of the Local cultural and historical heritage;
- g. Declare and maintain Local Heritage Zones;
- h. Establish a Local Registry of Cultural Property;
- i. Acknowledge the importance of traditional folk artist as singular conduit between skills of the past and the future;
- j. Revitalize a community artistic tradition thereby protecting a valuable fact of Philippine culture;
- k. Provide mechanism for identification and assistance for qualified traditional folk artists to transfer their skills to the community; and,
- l. Create opportunities for popularizing their works locally.

Section III. Secretariat. There shall be created a Secretariat which shall provide the technical and administrative support to the Local Council for Culture and the Arts. It shall be composed of the following:

Section IV. FUNDINGS

All expenses necessary and incidental to the effective implementation of the operations of this council shall be charged to funds made available for the purpose either through the Annual Budget or the Supplemental Budget.

Section IV. EFFECTIVITY

This Executive Order shall take effect immediately and shall remain effective unless sooner revoked or modified.
