**RECONSTITUTING THE LOCAL SCHOOL BOARD**

By the power vested in me as Municipal Mayor of this municipality, pursuant to Title Four, section 98 (3) of R.A 7160, the Local School Board is hereby reconstituted”

**Section 1. Composition.** The Municipal School Board shall compose of the following persons:

**Section 2. Functions.** The Municipal School Board shall have the following functions:

1. Determine the Annual Supplementary Budgetary needs for the operation and maintenance of public schools within the municipality and the supplementary local cost of meeting such needs, which shall be reflected in the form of an annual school board budget corresponding to its share of the proceeds of the special levy on real property constituting the Special education Fund and such other sources of revenue;
2. Authorize the Municipal Treasurer to disburse funds from the Special Education Fund;
3. Serve as an advisory committee on educational matters;
4. Recommend changes in the names of public schools.

**Section 3. Budgetary Allocation.** The Annual School Board Budget shall give priority to the following:

- a. Construction, repair and maintenance of school buildings and other facilities of public elementary and secondary schools;
- b. Establishment and maintenance of extension classes where necessary; and
- c. Sports activities at the Division District, Municipal, Barangay Levels.

**Section 4. Repealing Clause.** All prior orders, memoranda, or any parts thereof, inconsistent with the provisions of this Order are hereby revoked or modified accordingly.

**Section 5. Effectivity.** This order shall take effect immediately.
