

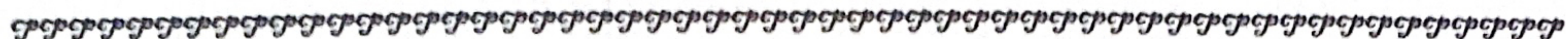

**REORGANIZATION OF LOCAL COMMITTEE ON ANTI-TRAFFICKING AND VIOLENCE AGAINST WOMEN AND THEIR CHILDREN (LCAT-VAWC)**

**WHEREAS**, Republic Act No. 9202 declares that te state shall give highest priority to the enactment of measures and development of programs that will promote human dignity, protect people from the violence and exploitation, eliminate trafficking in persons to ensure their recovery rehabilitation and reintegration;

**WHEREAS**, Republic Act 9262, on the other hand, underscores the commitment of the State on safeguarding the dignity of women and children while guaranteeing full respect of their human rights and to protect to them from violence and threats to their personal safety and security;

**WHEREAS**, Republic Act No/ 9710, otherwise known as the Magna Carta of Women, is a comprehensive women’s rights law that seek to eliminate discrimination against women by recognizing, protecting, fulfilling and promoting the rights of Filipino women, especially those in the marginalized sectors;

**NOW, THEREFORE**, I. MA. CARIDAD P. CLACIO, Municipal Mayor of the Municipality of Quezon, Province of Quezon, by virtue of the powers vested in me by law hereby order:

**Section 1. The Local Committee on Anti-Trafficking and Violence Against Women and Their Children (LCAT-VAWC) is reorganized with the following , to wit:**

**Section 2. Functions.** The Local Committee on Anti-Trafficking and Violence Against Women and Children:

1. Institute policies and programs to protect women and children who are victims of trafficking and violence
2. Create and establish system of surveillance investigation and rescue to ensure effective and efficient coordination.
3. Undertake information, education and advocacy campaign against trafficking in persons and VAWC.
4. Monitor and oversee the strict compliance of RA 9208, RA 9262 and other related laws for the protection of women and children and of the LCAT and VAWC national plans of action.


**Section 3. Secretariat**

The Secretariat support shall be lodged with the Municipal Social Welfare and Development Office, who shall be responsible for the documentation of proceedings of meetings and preparation of reports and other necessary documents as needed by the council/committee.

**Section 4. Repealing Clause.** All rules, Orders and other issuances inconsistent with the provision of this Order are hereby repealed, amended or modified accordingly.

**Section 5. Effectivity.** This Order shall take effect immediately upon approval thereof and shall remain in full force and effect unless sooner revoked or amended by the Local Chief executive.
