

EXECUTIVE ORDER NO. 20

Series 2021

REORGANIZING THE MUNICIPAL PROJECT MONITORING COMMITTEE (MPMC)

WHEREAS, the Department of Interior and Local Government issued Memorandum Circular No.20014-78 dated June 22, 20014 on the Organization/Reactivation of PMCs in the Local Government Units;

WHEREAS, Executive Order No.376 s. 1989, as amended by EO 93 s. 1993, established the Regional Project Monitoring System (RPMES) to facilitate project implementation and devolve facilitation, problem-solving, monitoring and evaluation of foreign, national and locally-funded projects to the sub-national levels;

WHEREAS, the RPMES is to be implemented by the development councils or planning boards at the regional, provincial, city and municipal levels;

WHEREAS, the aforementioned Eos states that PMCs originally established as the monitoring arm of the Local Development Councils under Memorandum Circular No. 175 dated May 23, 1988 were tapped to operationalize the RPMES at the sub-regional level;

WHEREAS, PMCs monitoring responsibilities were expanded to include: (1) foreign and nationally-funded projects including development projects funded from the Internal Revenue Allotment (IRA) share of LGUs or supported by funds released directly to the province, city or municipality and (2) projects funded from locally-generated resources which are implemented within their respective areas;

NOW THEREFORE, I, MA. CARIDAD P. CLACIO, Municipal Mayor of Municipality Quezon in the Province of Quezon, by virtue of the powerss vested in me by law, and in consonance with the provisions of Memorandum No. 2004-78, do hereby order the following:

SECTION 1. COMPOSITION

The Project Monitoring Committee (PMC) of Quezon, Quezon is hereby reorganized, which shall be composed of the following members:

SECTION 2. SECRETARIAT

The Secretariat support shall be provided by the Municipal Planning and Development Office (MPDO). The Municipal Planning and Development Coordinator (MPDC) shall submit monthly reports on the status of implementation of all National Government Funded Projects in the locality.

SECTION 3. MEETINGS

The MPMC shall met at least once every quarter or as often as may be necessary.

SECTION 4. REPEALING CLAUSE

All prior issuances inconsistent herewith shall be deemed superseded by this Order.

SECTION 5. EFFECTIVITY

The Executive Order shall take effect immdiately.
