AN ORDER RECONSTITUTING THE MUNICIPAL NUTRITION COUNCIL OF THE LOCAL GOVERNMENT OF QUEZON, QUEZON

WHEREAS, proper nutrition for our children is a must for them to grow physically and mentally fit so that they may become active in their early and formative years which stage is very critical of how would they become in their learning or schooling years;

WHEREAS, improper nutrition or malnutrition affects the physical growth and mental development of a child thereby affecting also his/her academic performance. Malnourished children are usually observed to be slow learners and lack interest in going to school;

WHEREAS, malnutrition if not prevented will result to recurring illness among children due to lack of resistance and immunity to bacterial and viral infections which in some cases result to deaths;

WHEREAS, the MNC is deemed to be the proper body that would see to it that proper nutrition program and activities would be carried out in all the 24 barangays of the Municipality of Quezon.

WHEREFORE, foregoing premises considered, by virtue of the power vested in me by the Local Government Code of 1991 also known as Republic Act 7160, I, MA. CARIDAD P. CLACIO, Municipal Mayor of Quezon, Quezon hereby reconstitute the Municipal Nutrition Council of the Municipality of Quezon to be composed of the following:

DUTIES AND FUNCTIONS.

The Duties and Functions of Municipal Nutrition Council shall be the following :

1. Formulate and implement local food and nutrition policies, plans and intervention for nutrition improvement.
2. Monitor and evaluate the efficiency and effectiveness of the plan for Nutrition improvement.
3. Identify and mobilize local resources for Nutrition Intervention programs and activities.
4. Advocate local support for the Nutrition Plan of action to sustain the Municipal Nutrition Program.

EFFECTIVITY. This Executive Order takes effect immediately. Any existing order found inconsistent thereto shall be deemed repealed or modified.
