**RECONSTITUTION OF THE MUNICIPAL INTER-AGENCY COMMITTEE (MIAC) FOR KC-NCDDP  
2021 IMPLEMENTATION**

**WHEREAS**, the Department of Social Welfare and Development and the Municipality of Quezon have entered into a General Memorandum of Agreement for the purpose of continuing the development and implementation of social protection programs under the Kalahi CIDDS-NCDDP 2021 that would further address the needs of Quezon LGU's poor, empower its citizen's and promote inclusive growth municipality-wide;

**WHEREAS**, the Local Government Unit of Quezon is mandated to provide technical support and assistance to KC-NCDDP 2021 Implementation;

**NOW, THEREFORE**, I, MA. CARIDAD P. CLACIO, Municipal Mayor of Quezon, by virtue of the power vested in me by law, do hereby order and direct the following:

2. **Function:** The Municipal Inter-Agency Committee (MIAC) is reconstituted for KC-NCDDP 2021 Implementation to function as follows:

2.1 To provide overall guidance and direction in the implementation of KC-NCDDP sub projects in accordance with the doctrine and principles of the community- driven development approach;

2.2 To provide technical support and assistance to the barangays in the preparation of their development plans and sub-project proposals;

2.3 To review, approve and endorse Request for Fund Release (RFR's)

2.4 To assist the KC-NCDDP coordinating teams in monitoring the implementation of barangay sub-projects funded by DSWD but co-implemented with Quezon LGU; and

2.5 Such other role(s) and function(s) that may henceforth be required by the circumstances.


3. **Meetings:** The MIAC shall convene at least once a month to discuss the status of KC-NCDDP 2021 program implementation including plans for providing technical support to Quezon LGU's 24 barangays.

4. **Funding Requirement.** The Municipal Government shall appropriate the amount of Seven Hundred Thirty Five Thousand (Php 735,000.00) for the operations as Local Counterpart Contribution.

5. **Repealing Clause:** This executive order repeals, cancels and/or modifies, as the case may be, any and all previously issued executive orders, particularly EO-026 (s. 2014); EO-033 (s. 2015); EO – 20 (s. 2016) & EO-012 (s.2018).

6. **Effectivity:** This administrative order shall take effect immediately.
